# Neighborhood News from A.T.N.A.

The Argay Terrace/PSU/Better Blocks grant made it through to the second round! This project is called the Argay Terrace Transformation and seeks to transform the intersection of NE 131st and NE Prescott Dr from a dangerous corner into a welcoming neighborhood space, in a community which is 47 percent Black, Indigenous and people of color. During this Fall semester at PSU, 4 graduate students are initiating a study of how Argay Terrace's roads could be safer for all. The plan will allow ATNA to note to the city where there are deficiencies and advocate for improvements. ProLogis/Kmart Warehouse: Thanks to the neighbors who attended the November 5 meeting with Commissioner Jaypal and Neighbors for Clean Air (NCA). Parkrose School District representatives expressed grave concerns about the air quality impacts on students at the HS. They noted that students, who will be impacted by increased traffic and diminished air quality, should be part of the discussion. Commissioner Jayapal indicated that the county does not have power over zoning, but they do have power over resident's health outcomes. Air quality data for our area show that residents are already at a higher risk for poor health impacts. With more diesel fumes in Argay Terrace from the placement of two freight warehouses (NE 122nd and NE 138th). air quality will diminish further.

ATNA continues to advocate for BDS to require studying off-site impacts as a factor in permitting decisions. NCA are offering air quality monitors and are willing to help Parkrose and Argay Terrace Neighborhoods negotiate a good neighbor agreement with ProLogis, should city permits go through. #### Future DEQ related activity in the area -

- ECR at NE 122nd and San Rafael is due to renew their permit.
- Feed Commodities LLC, 4441 NE 148th, has been issued a warning letter from DEQ as they are operating without a permit. They will need to apply for a Solid Waste Permit. They gather old bakery items and turn them into animal feed. The NE 148th site is a gathering and transfer site; processing occurs elsewhere.
