SECRETARY MINUTES –

TREASURERS' REPORT –Irene Hennessey, Leo Zinn

BUDGET – Chair Leo Zinn

- After the withdrawal of funds to cover the repaving expense, the Reserve Account is \$122,069.
- The good news is that the repaving was under budget by \$3,000.
- Administration Expenses are over budget by \$3,376
- If the January bill for Landscaping is added, they are about even for the year.
- The \$41,990 for paving brought Maintenance over budget \$4,610 year to date.
- Pool expenses are over \$1,753
- Utilities are over \$13,668 (Water is the biggest culprit at \$12,812 over for the year).
- Overall, Operating Expenses are exceeding the Budget by \$18,824.
- The Reserve Study calls for \$4,000 a month to be added we have not been able to do that.

ARCHITECTURE – Chair Patrick Steininger (absent)

it was brought up that a Resident on DW40 wants a new patio door. Jim will discuss with the Resident.

LANDSCAPE – Chair Kris Clarke (absent)

Nothing to report.

MAINTENANCE

- Water and sewer breaks were reported on various driveways.
- Also, a house on DW40 has been uninhabited for two years and was found to have had severe water leak(s). Jim has spoken to the Water Bureau about a reduction in the bill, however, the Bureau wants to see confirmation of repairs before they will discuss a reduction.
 - It was expressed that this situation could provide a lesson: in future, the HOA
 - Board could enter an empty home at some point to check for leaks or issues that might affect the HOA

- The bills for the various water issues are on separate accounts and so the resolution of each issue can be tracked.
- It was suggested by Jann that a payment plan be requested for these high bills, rather than remove more money from Reserves to pay the entire bill and (perhaps) have to deal with a credit at a later date.
- Larry suggested a notice in the Newsletter warning Residents of what a water leak could mean, both to the HOA and to the Resident. It could mention how to shut off water to the home or how to shut off water just to the outside faucet.
- At minimum, we should be covering our outside faucets with styrofoam covers, to help prevent freezing and then breaking upon thawing.
 - No one was assigned this action item.
- DW30 underground wiring was replaced.
