Committee News

Riverwood is a self-governed community. That means community volunteers are needed to keep Riverwood running smoothly. A full complement of volunteers lightens the load on all the committees. Getting volunteer needs met helps to keep our HOA fee lower as **we do not have to hire an outside management company.** There are 9 volunteers needed to fill our committee needs. These are noted on the BOD/Committees/Driveway roster. If you have yet to volunteer, please take a look at our needs and contact the committee chair to convey your willingness to help.

Insurance Committee: With all the new Homeowners at Riverwood, it seems a good time to bring attention to the requirement for individual Homeowner and Tenant comprehensive liability insurance. The minimum insurance coverage required by the Bylaws is \$100,000 and the HOA's Master Policy Deductible is \$25,000. This deductible is the responsibility of the Homeowner, in the case of a claim. Maintenance Committee: POSITION DESCRIPTION - RIVERWOOD MAINTENANCE COMMITTEE CHAIR: This is a very part-time position, averaging less than 5 hours per week, Ideally, you will be retired

CHAIR: This is a very part-time position, averaging less than 5 hours per week. Ideally, you will be retired, with time available throughout the week, which you will schedule as most convenient for yourself. You should be able to work to, and maintain, a very simple budget plan, preferably a computer spreadsheet; but it can be done on paper.

You will be responsible for management of maintenance, repair, and upgrade of: exterior surfaces of all Riverwood buildings; underground sewer and drain lines; underground water supply pipes; all hard paved surfaces (such as blacktop driveways and concrete walkways); security lighting, fences, and Clubhouse facilities.

"Manage" does not mean to actually perform the tasks. It means only to organize and direct; there are sufficient resources, technical knowledge, and experience available to assess and perform whatever tasks you may encounter and to inform and advise you, whatever the case may be. You will have strong backup and support. Therefore, you need not be a carpenter, or plumber, or electrician; or even have worked for a construction or maintenance company. Indeed, experience as a homeowner faced with the usual handyman projects and tools would be a serious plus.

Typical tasks will be:

- Schedule annual projects from the "Budget & Plan" with the working resources by priority and seasonal requirements.
- Track task starts & stops and costs: to maintain a record, provide a basis for future estimates, and assist in building next year's Budget & Plan.
- As unexpected tasks arise, reschedule resources by priority, and plan & track interruptions and expenses as they occur.
- Receive maintenance requests from homeowners, assess their legitimacy and assign themto working resources by priority.
- Near the end of the year, build the next year's Budget & Plan.
- Work with, and report monthly to, your representative on the Board of Directors. Your rep is there to help you, to provide knowledge, guidance, and support. You will rapidly become a key member of the Riverwood management team, and a deeply appreciated resource to all your neighbors.

<u>From Jim</u>: Would the person who took the new, boxed set of "Double-Twelve" dominoes from the Rec Room please return them? They are not for borrowing.

Ever wonder where the name MontaVilla came from? Well, it was a thinly-populated area in the 1880's, but a growing neighborhood, known technically on the survey maps as Mount Tabor Village. When the municipal

streetcar system reached it, their destination signs did not have room for the entire name, so they abbreviated it to "Mt. Ta. Villa." By the 1890's, the signs had become "Monta. Villa." That apparently had a nice ring to it because residents adopted it and it eventually became the official name: MontaVilla.

Regarding DW 20's water being turned off: a Renter had a leak. The Homeowner called a plumber, who did not want to turn off the house water valve, so instead turned off the driveway water. This happened twice. The Board will be looking into new rules about individual homeowners shutting off community water.
